25/01103/FULL Cannington Farm Witheridge Change of use from agricultural building to B8 storage

Mr W Martin (Applicant), and Colleague, spoke on this application and were disappointed that the Parish Council had failed to support it, and were unhappy with the negative response. The site in question comprised of a grain store and an existing building that was approved under an agricultural Prior Notification.

An existing access had been approved for associated agricultural traffic.

This proposed location for sustainable expansion would increase local employment to 25-30 high-skilled positions and contribute annually to the local economy.

A discussion then followed with questions being raised by Parish Councillors.

The Applicants Colleague was insistent that "The Parish Council within 7 days of receiving a Planning Application were obliged to call a Public Meeting to discuss".

The Clerk responded to say during his many years as Parish Clerk for other Parishes he was not aware of this.

It was agreed the Parish Council would discuss the application formally later in the Meeting under the Agenda item for Planning.

Mr S Cole (Applicant) spoke on behalf of this application and was disappointed that the Parish Council had failed to support it.

"Menchine Farm" was a working farmstead comprising of the main farm, with poultry houses, an anaerobic digester plant and agricultural fields.

If granted the application would support the current construction of 155 new homes in Witheridge. and would also provide Rural Employment.
