I. Apologies for absence

There were none.

II. Approval of minutes from last meeting

The minutes for 8th May 2019 were signed as a correct record.

The Black Dog defibrillator cost c£3,000 with a heavy duty box and electrical supply, but with British Heart Foundation grant funding for half the cost a further £1,500 was raised by the community through fund raising. The grant was with the proviso that some people had first aid training.

III. Public forum

One member of the public attended.

IV. Declarations of interest

Cllr Grant declared an interest with respect to the Wick Lea planning prior notification since this was formally his mother's home.

V. Clerk's report

Councillor Resignation

Cllr Charlton has resigned; the elections office has been notified and the vacancy advertised. Since he was to be Vice Chairman and an authorised signatory, an alternative councillor is now required.

Funding

Two Devon County Schemes are open to legally constituted and registered as not-for-private-profit organisations including town and parish councils, voluntary, community and social enterprises, charities and business. Applications can also be made by a combination of groups working together.

The new Doing What Matters Community Grants Fund is now live. This offers one-off grants of between £5k to £20k to successful community project applicants. The scheme features an intervention rate of 75% (25% match required).

Another grant fund called Making the Connection, provides small, one-off grants of up to £300 to support community-led ideas and initiatives across Devon. No match funding is required.

Making Tax Digital

Where a council is not VAT-registered and reclaims using a VAT126 form, it will NOT be affected during 2019/20, nor does it seem likely this will change in 2020/21.

Action for Wildlife Conference

The Devon Community Action for Wildlife Conference is being held on 6th July in Chagford. It is hoped as many parish representatives attend as possible.
