- VII. Defibrillator
 - a For Thelbridge

Cllr Squires has provided a £350 grant from her locality budget. The Thelbridge Cross Inn is happy to host the defibrillator and are willing to help with fund raising. An article is going into the Witheridge Group Newsletter asking for donations. The Platinum Jubilee event at the Cricket Club raised £1,500 for charity, £500 is being donated and Menchine Farm will donate another £500 for the Thelbridge defibrillator. Such a significant contribution was very much appreciated. There will be further fund raising at the Nomansland Cricket Club on 26th August with a paella night. b Request from Cruyws Morchard Parish Council
