Public Session

There were no questions from members of the Public. The Chairman said that he would accept questions from the Public for items on the agenda at the relative times. Minutes of the previous meeting were read and agreed and duly signed by the Chairman.

Matters Arising

Roberts outline planning for a dwelling to replace a mobile home. The Chairman said that he had attended a Planning Meeting at Mid Devon Council and had spoken in favour of the application. The Clerk reported that he had received notification that Mid Devon Planning Authority had rejected the application and read out to the meeting the reasons for refusal, the application was also recommended strongly for refusal by North Devon District Council, Councillor S.J.D. Hayes said that he was in favour of the proposed application and did not agree with the Council's decision.

The Clerk reported that he had informed Mid Devon Planning Authority of the decision reached regarding hangar worthy construction of 16 homes at Nonansland. Mr Smythe, resident of Nonansland said that the developer had met with a small group of residents as agreed.

Traffic Management - Nonansland

The Clerk reported that the lower speed limit through Nonansland had been introduced. Mr. Best, resident of Nonansland said that H.M.P.H was still marked on the B3137 roadway.

Proposal for the possible lease of land at Nonansland to provide a Cricket Pitch + Childrens Play Area.

Mr. P. Bligh stated that plans were being formulated to lease a field from Mr. Cole to provide a Cricket Pitch. He said that a Childrens play area could also be incorporated into this scheme, which would also include changing rooms + a toilet, and suggested a partnership with the Parish and District Councils, with the possibility of funding coming from this source.

Mr. Best said that he considered the location was too far from the village centre, also children would have to negotiate the B3137 which could prove to be dangerous.

The Clerk said that he understood from Mr. Charlton that access to the field could be through his gateway.

District Councillor R. Quick suggested that a Sub Committee could be set up to look into the proposals. No decision was reached. This item was to remain on the agenda.

Correspondence.

A letter was read from Mr. Best regarding the repositioning of a Pillar Box and the location of the telephone box.

After a debate the residents of Nonansland present voiced their

opinion, that both the pillar box and telephone box should remain. Mr. Beet pointed out that the majority of residents present did not come from within the Parish of Thelbridge. Councillors supported the majority of the public present.
